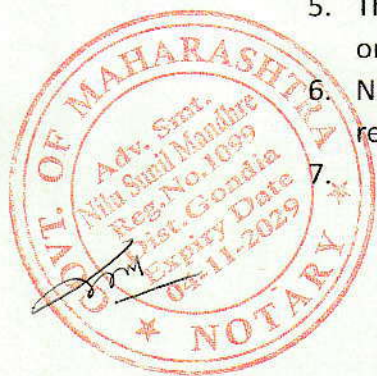


- Management** : Operated by the Chairman/Secretary, Swami Vivekananda Education Society, Gondia.
- Subject** : Regarding the issuance of a Recognition Certificate to schools under Section 18 of the Right of Children to Free and Compulsory Education Act, 2009, and Rule 11, Sub-rule (4) of the Right of Children to Free and Compulsory Education Rules, 2011.
- Reference** : Based on your application dated 18/05/2023 and subsequent correspondence/inspection of the school.

I, the **Education Officer (Primary), Zilla Parishad, Gondia**, hereby grant temporary recognition to **Vivek Mandir School, Hariom Colony, Gondia, Taluka/Dist. Gondia** for Classes 1st to 7th for a period of 3 years, from **01/07/2023 to 30/06/2026**.


**This recognition is subject to the following conditions:**

1. The recognition period will not be extended, and there shall be no obligation to grant recognition or affiliation beyond Class 8th under any circumstances.
  2. The school shall comply with the provisions of the Right of Children to Free and Compulsory Education Act, 2009 (Annexure 1) and the Maharashtra Right of Children to Free and Compulsory Education Rules, 2011 (Annexure 2).
  3. The school shall admit children from weaker sections and disadvantaged groups in the neighborhood in Class 1 to the extent of at least **25% of the strength** of that class and provide free and compulsory elementary education till its completion. This shall also apply to pre-primary classes.
  4. For the children referred to in Paragraph 3, the school shall be reimbursed as per Section 12(2) of the Act. To receive such reimbursement, the school shall provide a separate bank account.
  5. The society/school shall not collect any capitation fee and shall not subject any child or their parents/guardians to any screening procedure.
  6. No child shall be denied admission to the school on the grounds of lack of age proof, religion, caste, race, place of birth, or any of these reasons.
- (One) No child admitted to the school shall be held back in any class or expelled from school until the completion of elementary education.
  - (Two) No child shall be subjected to physical punishment or mental harassment.
  - (Three) No child shall be required to pass any Board examination until the completion of elementary education.
  - (Four) Every child completing elementary education shall be awarded a certificate as laid down under Rule 23.

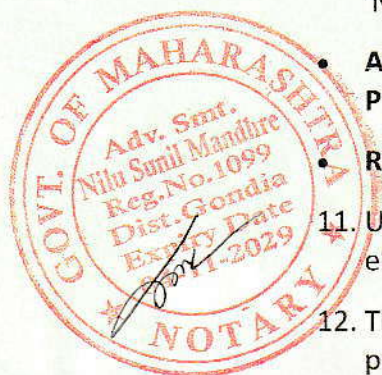

- (Five) Students with disabilities/special needs shall be included as per the provisions of the Act.
  - (Six) Teachers shall be appointed who possess the minimum qualifications as laid down under Section 23(1) of the Act. Provided further that teachers who do not possess minimum qualifications shall acquire them within a period of 5 years.
  - (Seven) Teachers shall perform their duties as specified under Section 24(1) of the Act.
  - (Eight) Teachers shall not engage themselves in private tuition activities.
8. The school shall follow the syllabus prepared on the basis of the curriculum laid down by the appropriate authority.
9. The school shall admit students in proportion to the facilities available in the school as prescribed in Section 19 of the Act.
10. The school shall adhere to the norms and standards specified in Section 19 of the Act. At the time of the last inspection, the facilities available in the school were as follows:
- **Total area of school premises** : 8500 Sq. Mtrs.
  - **Total built-up area** : 4500 Sq. Mtrs.
  - **Area of the playground** : 4000 Sq. Mtrs.
  - **Number of classrooms** : 48
  - **Office-cum-Store-cum-Headmaster's room** : 16
  - **Separate toilets for boys and girls** : Available (with adequate water to keep them clean and hygienic).
  - **Drinking water facility** : Available
  - **Kitchen for cooking Mid-day Meal** : Not Available (indicated by a tick on 'No').
  - **Availability of Teaching-Learning Material / Play & Sports Equipment / Library** : Available
  - **Reading material available without cost** : Available
11. Unrecognized classes or sections shall not be operated within the school premises or elsewhere.
12. The school building or other structures and the playground shall be used only for the purposes of education and skill development.
13. The school is being run by a society registered under the Societies Registration Act, 1860 (21 of 1860) or the Mumbai Public Trusts Act, 1950.
14. The school is not run for the profit of any individual, group, or association of persons.
15. The school accounts should be audited and certified by a Chartered Accountant, and a proper accounts statement should be prepared as per rules. A copy of the relevant accounts statement should be sent to the District Education Officer every year.
16. The recognition code / **UDISE Number** allotted to your school is **27110416605**. Please mention this number in all future correspondence with this office.

19. Other conditions as per "Annexure 3" are attached herewith.


